WARNING: Under the Michigan Equine Activity Liability Act [1994 P.A. 351], an equine professional is not liable for an injury to or the death of a participant in an equine activity resulting from an inherent risk of the equine activity.

By signing this agreement you are giving up certain legal rights, including but not limited to the right to recover damages in case of injury, death, or property damage arising out of your riding or use of the Owner's horse and/or participation in equine activities with Dowd Equestrian, LLC and Taylor Dowd including injury, death, or property damage arising out of the negligence of you or Taylor Dowd or Dowd Equestrian, LLC. Your signature below indicates that you have read and fully understand this agreement.

WHEREAS, the undersigned acknowledges that inherent risks involved in riding and working around horses, which risks include bodily injury from using, riding, or being in close proximity to horses, including but not limited to: bites, kicks, abrasions or contusions from horses; being thrown or bucked off by horses; injury from stalls or enclosures, from grooming tools and other equine tack; allergic reactions to animals, hay, or other allergens; slipping, falling, or otherwise being injured in the barn or on the grounds which can be slippery, wet, or contain or present other hazards, and further, that both horse and rider can be injured in normal use or in competition and schooling.

IN CONSIDERATION, therefore, the privilege of riding and/or working around horses with Dowd Equestrian, LLC, Taylor Dowd, and their landlords or other affiliated persons, the undersigned does hereby agree to hold harmless and indemnify Dowd Equestrian, LLC, Taylor Dowd, and their landlords or other affiliated persons personally, and further release them from any liability and responsibility from accident, damage, injury, or illness to the undersigned or any horse owned by the undersigned while working with Taylor Dowd and Dowd Equestrian, LLC.
